

## **SCHOOL-PARENT COMPACT**

### **School Responsibilities**

**York Academy will:**

*SCIENCE: FOSS Science program, STEMscopes  
International Baccalaureate (IB) Curriculum*

- 2. Hold parent-teacher conferences during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:

*Parents will be provided with information on scheduling student-led conferences twice a year or as requested by the parent or teacher.*

- 3. Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:

*Parents receive report cards three times a year. The teachers will meet with parents to discuss the child's progress during the student-led conference. Additional progress reports will be provided on an as need basis.*

- 4. Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:

*Staff will be available at Back to School Night, dismissal at the end of the day, and at the request of parent, teacher, or family support team. A meeting will be scheduled to accommodate all parties involved. All staff and parents are strongly encouraged to attend all events that occur at York Academy.*
